
IMPORTANT ANNOUNCEMENT

YOUR SEPTIC SYSTEM IS OWNED AND MAINTAINED BY THE TOWN AND THESE STICKERS WILL CONTAIN IMPORTANT INFORMATION IN THE EVENT THE SEPTIC ALARM SOUNDS.



WATER/SEWER/SEPTIC SYSTEM EMERGENCIES

The Town's sewer system has seen an increase in non-flushable items. Only toilet paper and waste from the human body should be flushed down the toilet. Even items that say *flushable*, like hygiene/disinfecting wipes, should <u>not</u> be flushed. Other unsafe items include:

- Disposable diapers (adult &
 Condoms Hair baby)
- Sanitary napkins or tampons

Dental floss

- Cigarette butts Paper towels or bandages Coffee grounds
 - Kitty litter

Please do your part to keep our system the best it can be. It is also very important that you not park vehicles on top of water meters or block them in any way. For water, sewer and septic emergencies, contact Tony Caldwell at (360) 947-4734.




IMPORTANT UTILITY BILLING INFORMATION

If someone calls you and threatens to shut off your service without an immediate payment, hang up and call the number on your bill. This applies to all of your utility providers.

BE SURE YOUR PAYMENT IS PROCESSED CORRECTLY: Payment is always due by the 19th of the month. If not paid by 8 a.m. on the morning of the 20th, a \$25 late fee will be assessed and a late bill generated. If not paid by the 27th, the water will be shut off on the 28th, vou will incur a \$50 shut off fee, and a \$50 turn on fee, which must be paid with the full balance before water service, will be restored. Keep in mind our mail service in Town is very slow and unpredictable. The best way to ensure your payment is received on time is to drop it in the drop by at Town Hall no later than the 19th.

RECENT COMPLAINTS

There have been numerous complaints lately that are in direct violation of the South Prairie municipal code. Some of those violations should be reported to the sheriff or animal control in order to be addressed properly. They are detailed below:

Parking on 3rd street SE— There have been vehicles parking along 3rd street that are blocking the view to safely navigate the corner from A.P. Tubbs Road. When parking on the road, ensure that you are fully out of the roadway. Please Make sure you are not parked within 30 feet of stop signs, within 15 feet of fire hydrants or pedestrian right of ways, or within 5 feet of neighbors driveways.

Public Disturbance Noises - The afterhours (11:00pm - 7:00am) use of off highway vehicles (OHV's) violates SPMC noise code. OHV's include all-terrain vehicles (ATV's), four wheelers, three wheelers, dirt bikes, motorcycles, trail bikes, mini bikes and snow mobiles. SPMC 9.25.010 states "It is unlawful for any person knowingly to cause or make, or for any person in possession of property to knowingly allow or permit to originate from the property, а public disturbance noise which unreasonably disturbs another. This also applies to Town streets.
