WATER/SEWER/SEPTIC SYSTEM EMERGENCIES


The Town's sewer system has seen an increase in non-flushable items. Only toilet paper and waste from the human body should be **flushed** down the toilet. Even items that say **flushable**, like hygiene/disinfecting wipes, should <u>not</u> be flushed. Other unsafe items include:

Coffee grounds

Kitty litter

- Disposable diapers (adult & baby)
- Sanitary napkins or tampons Paper towels or bandages
- Oental floss
- Condoms
- Hair
- Cigarette butts

Utility Billing Information

Now you can pay your bills online! As a way to offer you more choices in how you pay your bills. we have partnered with Xpress Bill Pay.

It's simple to use, all you need is an internet connection and an email address. Once you sign up for your account and start using this service, every month we'll send you a reminder email to let you know when your bill is online. Then, you just log into your account at www.xpressbillpay.com or use our mobile app to view your bill.

When you're ready to pay your bill, select a payment type. You can pay with credit card, debit card, or electronic funds transfer. Enter the information and you're done! Or you can set up your bill on Auto Pay and have it automatically paid for you each month! We offered this service at the request of our customers — you asked and we delivered!

To sign up, go to www.xpressbillpay.com and follow the instructions there.

If someone calls you and threatens to shut off your service without an immediate payment, hang up and call the number on your bill. This applies to all of your utility providers.

BE SURE YOUR PAYMENT IS PROCESSED CORRECTLY: Payment is always due by the 19th of the month. If not paid by 8 a.m. on the morning of the 20th, a \$25 late fee will be assessed and a late bill generated. If not paid by the 27th, the water will be shut off on the 28th, you will incur a \$50 shut off fee, and a \$50 turn on fee, which must be paid with the full balance before water service, will be restored. Keep in mind our mail service in Town is very slow and unpredictable. The best way to ensure your payment is received on time is to drop it in the drop by at Town Hall no later than the 19th.

South Prairie Flag **Design Contest**

Do you have an undeniable artistic ability? This contest might be just for you! Most Towns and Cities have a flag that symbolizes the pride they have for their community.

Five Principals for flag design, suggested by the North American Vexillological Association:

- 1. Keep it simple. The flag should be so simple that a child can draw it from memory.
- 2. Use meaningful symbolism. The flags images, colors, or patterns should relate to what it symbolizes.
- Use 2-3 basic colors. Limit the number of colors on the flag to three which contrast well and come from the standard color set.
- 4. **No lettering or seals**. Never use writing of any kind or organizations seal. *Note: Use of the Towns logo and name* is allowed in this contest
- Be distinctive or be related. Avoid duplicating other flags, 5. but use similarities to show connections.

RCAC Income Study

KEEP AND EYE ON YOUR MAIL FOR THIS IMPORTANT SURVEY

RCAC is continuing to conduct an income survey regarding your Household Gross Annual Income for 2021.

This information is needed so the Town can apply for funding programs to allow for necessary repairs and replacements to the wastewater system. Being able to seek necessary funding to make much needed upgrades to the system without heavily impacting user rates.

There were approximately 25 homes that have not yet responded. You will be receiving a direct mailing with the information needed to respond. We are so close to certifying the survey and your participation is vital.

Rural Community Assistance Corporation (RCAC) is an independent third-party organization conducting the survey. The information you provide will only be used by RCAC and will be kept confidential. No State, County, City, District, or community members will have access to any individual's response.

Code Enforcement

There have been numerous complaints lately that are in direct violation of the South Prairie municipal code. Some of those violations should be reported to the sheriff or animal control in order to be addressed properly. They are detailed below

Animal Control Violations - There have been reports of roaming (off leash) and aggressive animals . We should not have to feel unsafe in our own neighborhoods due to irresponsible pet owners. Animal bites, animals running loose, cruelty reports, injured animals and vicious animal complaints should be made to Pierce County Animal Control (PCAC). Please contact them directly at 253-798-PETS. SPMC 6.05.010 - Adoption of Pierce County Code relating to animal control. PCC 6.03.010 (A) It is unlawful for the owner or person having control or custody of any animal to cause or permit such animal to leave the premises where the owner resides, unless the animal is under physical restraint adequate to the size and nature of the animal. Exceptions to this restriction are pets engaged in formal training, hunt or competition, or animals lawfully within a designated off-leash park, or service dogs engaged in activity for which they are trained or in service. Any such animal may be seized and impounded. A violation of this subsection is a Class 3 Civil Infraction.

Public Disturbance Noises - The afterhours (11:00pm - 7:00am) use of off highway vehicles (OHV's) violates SPMC noise code. OHV's include all-terrain vehicles (ATV's), four wheelers, three wheelers, dirt bikes, motorcycles, trail bikes, mini bikes and snow mobiles. SPMC 9.25.010 states "It is unlawful for any person knowingly to cause or make, or for any person in possession of property to knowingly allow or permit to originate from the property, a public disturbance noise which unreasonably disturbs another. This also applies to Town streets.

We all love our Town so let's be good neighbors and allow everyone to safely enjoy our community and neighborhoods!

Did you know that one of the natural hazards facing residents of South Prairie is volcanic activity from Mount Rainier?

Experts consider it one of the most dangerous volcanoes in the world, largely because of the threat of a lahar. A lahar is a large volcanic mudslide caused by snow and ice melting from mountain glaciers. Mt Rainier has 25 large glaciers on its peak with a combined area of approximately 35 square miles. A lahar event with such close proximity of residents to the mountain, the damage could be catastrophic.

The Puyallup River Valley is at greatest risk. Tens of thousands of people live in areas that may have as little as 40 minutes to move to safety once a large lahar is detected. This robust system was originally created to notify people promptly and widely, they were in harm's way and how to prepare and take protective actions.

In response to this hazard, Pierce County Department of Emergency Management (PCDEM) has worked closely with other experts to create an integrated lahar warning system. The Mt. Rainier Lahar Warning System consists of two separate components, operating in tandem: Acoustic Flow Monitors (AFM) and the All Hazard Alert Broadcast (AHAB) sirens. There is an AHAB siren located at the South Prairie Fire Station. Along with the siren residents will also receive warning via PCALERT and other alerting mechanisms. You can sign up for PCAlerts by texting "PCALERT" to 888-777 from your mobile device.

In the event of a lahar emergency the system will use a "wail" siren and flashing lights to get people's attention. After the siren a verbal warning will sound in English and Spanish. There are routes mapped for resident evacuation and are indicated by signs on the main roads in South Prairie.
